The data were coded and entered into SPSS for statistical testing, including descriptive statistics to summarize demographic information and inferential analyses such as correlation and regression to identify the strength and direction of relationships between variables. This approach provided a clear understanding of how internet usage patterns influenced various aspects of students' physical well-being, including sleep quality, posture, and overall fitness.

# Results and Discussion (Mean and Standard Deviation Analysis)

The descriptive analysis in Table 1 shows that the mean scores for most items range between 2.4 and 2.8, suggesting a generally high level of agreement among respondents on the influence of social, economic, and personal factors on internet addiction. The highest mean (M = 2.83, SD = 0.45) was found for the statement "Lack of food drives me to guide my father in internet addiction," indicating that economic hardship is a major motivating factor behind internet

dependence. Similarly, strong agreement was observed in statements like "I do not know the means to earn money" (M = 2.70, SD = 0.55) and "I am internet addicted for medical purposes" (M = 2.70, SD = 0.58), highlighting the role of necessity and perceived utility in shaping online behavior. These findings suggest that internet addiction among students in Mardan is often associated with socioeconomic vulnerabilities rather than purely leisure or entertainment motives.

In contrast, lower mean values were observed for statements such as "I help my family through internet addiction" (M = 2.15, SD = 0.82) and "Single parenthood is the cause of internet addiction" (M = 2.10, SD = 0.83), indicating relatively lower agreement or variability in opinions. The moderate mean scores for psychological factors such as laziness (M = 2.42, SD = 0.68), negligence (M = 2.43, SD = 0.67), and alcoholism (M = 2.38, SD = 0.70) suggest that respondents perceive these as contributing factors, but not as strongly as poverty or lack of guidance. Overall, the results indicate that while personal behavior and social environment influence internet addiction, economic hardship and lack of alternative opportunities remain the dominant drivers, as reflected by higher mean values and lower standard deviations among poverty-related statements.

#### **Results and Discussion**

The results from Table 1 reveal a strong pattern of agreement among respondents regarding the multifaceted causes and consequences of internet addiction in Mardan city. A substantial proportion (90%) reported that a lack of food motivated them to guide or support their families through internet-related activities, indicating that economic hardship plays a critical role in shaping digital dependency. Similarly, 82.5% of respondents admitted not knowing alternative means of earning, further emphasizing the connection between limited livelihood opportunities and excessive internet use. High levels of agreement were also found regarding statements linking poverty (75%) and lack of orientation (70%) to internet addiction, suggesting that socioeconomic instability and insufficient awareness contribute to students' unhealthy online behaviors. Moreover, 77.5% of participants expressed a desire for self-reliance, reflecting a psychological dimension where dependence on the internet may be viewed as both an escape and a coping mechanism. The findings further indicate that several respondents viewed internet use as a survival strategy rather than a leisure activity. Approximately 70% agreed that income from internet-related work supports their daily needs, while 62.5% considered it an easy and profitable source of income. However, social and health-related factors also surfaced, with 70% reporting parental illness and 65% noting parental loss, which may increase emotional dependence on digital engagement. Interestingly, behavioral causes such as laziness (62.5%), negligence (62.5%), and alcoholism (60%) were also associated with internet addiction, indicating a complex interaction between personal habits and environmental pressures. Overall, these results highlight that internet addiction among students in Khyber Pakhtunkhwa is not solely a behavioral issue but deeply rooted in economic constraints, social dynamics, and lack of guidance, all of which demand targeted awareness and intervention programs.

#### Recommendations

For the government, it is essential to take effective measures to reduce internet addiction among students through welldesigned policies and regulations. The government should introduce awareness campaigns that educate youth about the healthy use of the internet and the potential negative effects of excessive online activity on physical and mental health. Additionally, implementing technology-driven professionally oriented educational policies can help students develop constructive online habits while enhancing their digital literacy. By promoting awareness about responsible internet use and ensuring that educational institutions integrate internet safety programs, the government can play a crucial role in minimizing internet addiction and safeguarding the well-being of students across Pakistan.

- The government should take some steps to reduce the internet addictionof internet addictionren through policies and regulations.
- There is an extensive need to launch technological and professional-based educational policies in Pakistan generating awareness about internet addictionren rights etc.
